Let's get Automated!

The Finance/Stewardship Committee encourages your regular monthly contributions to our congregation, known as automated giving. In other words, giving by a method that allows your gift to come straight from your account to the church.

What Are My Automated Options? **VANCO!**

Sign up for this option with forms available through the church or via download. This option moves money directly from your bank account to the church. There is a very small fee to the church for this service. *(The Vanco form is available on the church web site Stewardship page.)*

Direct Bill Pay From Your Bank

Many banks now offer direct bill pay from your account. Ask your bank if you don't already use this option. It is a wonderful way to pay utilities, housing—AND your gift to the church! There is no charge to the church, and depending on your account, often no charge to you.
